GENERAL INFORMATION

The City of Dillon is accepting proposals from qualified vendors to perform design engineering, permitting, and construction administration for Wastewater System Improvements for the City of Dillon. This work is being funded by a grant funds from the U.S. Department of Commerce Economic Development Administration and the City of Dillon and will be subject to all federal requirements pertinent to EDA projects.

SCOPE OF WORK/SERVICES

The wastewater system improvements to be undertaken are: replacing the existing 20" force mains currently located on an abandoned bridge deck with the installation of two new 20" force mains placed underneath the Little Pee Dee River by horizontal directional drilling; and tying in the new force mains to the existing lines on either side of the river; grassing; and abandoning the existing 20" force mains on the bridge.

A committee will evaluate the proposals based on the following criteria:

- 1. Previous Experience with EDA Grants 15% of evaluation
- 2. Proposed Approach to Project 10% of evaluation
- 3. Proposed Schedule/Time of Completion 20% of evaluation
- 4. Project Manager and Team Experience with Similar Work 20% of evaluation
- 5. Location of the Office Where the Work will be Performed 10% of evaluation
- 6. Previous Work Experience with the Owner 25% of evaluation

At that time, the names of the responding firms will be publicly announced as their responses are opened. An evaluation committee will review the proposals.
